Assoz. Prof. Fabio Wolkenstein, Ph.D.

*Department of Political Science
Faculty of Social Sciences*

Fabio Wolkenstein is Associate Professor of Transformations of Democracy at the University of Vienna. He is first and foremost a democratic theorist, with special focus on issues such as partisanship, political representation, and the history and theory of political ideologies, notably Christian Democracy. Most of his work transcends disciplinary boundaries, however, connecting philosophy, history, empirical social science, and legal scholarship. Prior to joining the University of Vienna, Fabio was Associate Professor of Political Science at Aarhus University and Affiliated Researcher at the University of Amsterdam.

Fabio was educated at the London School of Economics and Political Science, where he received his PhD in 2016, and spent a year as a post-doctoral researcher at *Justitia Amplificata*, a research centre for political and legal philosophy associated with the Goethe University Frankfurt and the Free University of Berlin. Thus far, Fabio has published two books, *Rethinking Party Reform* (Oxford University Press, 2019) and *Die dunkle Seite der Christdemokratie* (C.H. Beck, 2022). Two further books, *Political Representation as Communicative Practice* (Cambridge University Press) and *Democratic Regressions: Subversions of Popular Rule and Paths to Recovery* (Oxford University Press) are in progress and will appear soon.

Mag. Dr. Justin ARICKAL, MBA

Justin Arickal studied Economics and Business Management in Cologne, Bradford and Oxford and worked for a multinational company in various managerial roles. In 2013 he pursued his theological interests and studied Theology at the University of Bonn (Mag.theol.), where he also completed his doctorate at the Department of Fundamental Theology, Theology of Religions and Philosophy of Religion (Dr. theol.). In 2021 he conducted a research stay at Yale University with a focus on hermeneutics in contemporary Theology.

His research interests include interdisciplinary hermeneutics, (ambivalent) images of God ("Gottesbilder"), Christology, Pneumatology and more recently the intersection between theological anthropology and phenomenological philosophies of the human body. In September 2023 Justin joined the Institute of Systematic Theology and Ethics (Department of Dogmatics and History of Dogmatics) at the University of Vienna as Postdoctoral University Assistant.

Deniz Coşan Eke (Dr. phil.) is currently working as a postdoc researcher in Alevi Theological Studies at the University of Vienna in Austria. She received her Ph.D. in Social and Cultural Anthropology from the Ludwig Maximilian University of Munich in Germany. She has been a visiting researcher on transnational migration, religious groups, and interreligious dialogue at the University of Roskilde, the University of Westminster, and the University of Cambridge. She is the author of "The Changing Leadership Roles of "Dedes" in the Alevi Movement: Ethnographic Studies on Alevi Associations in Turkey and Germany from the 1990s to the Present" (Bielefeld: Transcript, 2021). She is co-editor with Eric Trinkaus of Religion, Religious Groups and Migration (Transnational Press, London, 2023).

She is a co-leader of the Cost Action 20107 project "Connecting Theory and Practical Issues of Migration and Religious Diversity" (COREnet). She is also co-leader with Handan Aksünger Kizil of a project at the University of Vienna entitled "Alevi Religious Education and Digitalization in Europe: Limits, Chances and Expectations."

Sandra Lehmann is a postdoctoral associate and deputy head of the Institute for Intercultural Philosophy of Religion at the University of Vienna. She habilitated in 2023 with a thesis on what she calls the hyperbolic character of being. Her background is in the philosophy of existence and phenomenology. She wrote her dissertation on the Czech phenomenologist Jan Patočka, whose work she also translated into German. Sandra Lehmann has held a number of fellowships, including the APART fellowship of the Aistrian Academy of Sciences, and fellowships at the Centre for Theoretical Studies in Prague, the Franz Rosenzweig Minerva Research Center in Jerusalem, and the Institute for Human Sciences in Vienna.

She has taught at several universities, including Charles University in Prague, the University of Seville, and the Catholic University of Linz. In addition to her metaphysical project, Sandra Lehmann's research is concerned with the development of a different economy of time (from the primacy of the future to the primacy of an intensified present) and the transformative quality of violence in religious systems, for example in religious initiation rites.

Mag. Dr. David NOVAKOVITS, BA MA

My name is David Novakovits and I work at the Institute for Practical Theology at the Faculty of Catholic Theology in the field of religious education as a post-doctoral assistant. My research interests focus on the relationship between religion and education generally and the possibility of collective educational processes in particular. The confrontation with educational, sociological and (religious) philosophical discourses is a research focus of mine.

In my dissertation, I have attempted to characterize the question of failure as a fundamental question about being human in the current cultural constellation and to make theological resources fruitful for religious learning processes in this confrontation with "failure". As a next step, I would like to explore a learning arrangement designed in the doctoral thesis in the course of an empirical project in the classroom and thereby pursue the question of to what extent and how students make use of the theological resources offered in order to deal with questions about being human in the context of failure.

Mag. Dr. Thomas SCHMIDINGER

Thomas Schmidinger studied Political Science and Social Anthropology at the University of Vienna. He is a lecturer at the Department of Political Science at the University of Vienna, at the University of Applied Sciences Upper Austria (Linz) and Associate Professor at the University of Kurdistan Hewlêr (UKH) in Erbil (Iraq). His research focuses on Iraq, Syria and Sudan as well as religious extremism, religious and ethnic minorities, transnational conflicts and state and religion. He has published on political Islam and Jihadism and most recently on Catholic traditionalism.

He is currently writing a book about the cultural remains of the Jewish communities in Kurdistan, which is being funded by the Future Fund of the Republic of Austria. Schmidinger also advises several Austrian members of the EU and parliament on Iraq, Syria and the Kurdish regions. Together with Alicia Allgäuer, curates the socio-political event series "Neue Spielräume" at Spielboden Dornbirn.

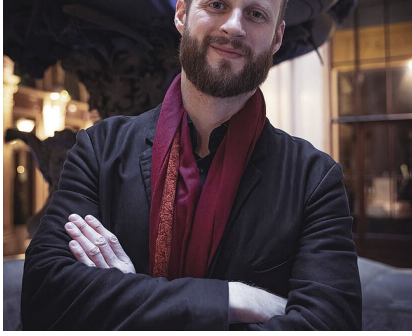
He is co-editor of the Vienna Yearbook for Kurdish Studies, which has been published since 2013.

Julian Strube has been a postdoctoral assistant at the Institute for Religious Studies since 2021 and a RaT member since 2023. Prior to this, he worked at the Universities of Hamburg, Heidelberg and Amsterdam (including as a substitute professor). His research focuses on the global history of religion, especially on the study of Indian religions, the question of the relationship between religion and politics and the role of esotericism and alternative religiosity. Among many other publications, this has already resulted in three monographs: " Global Tantra: Religion, Science, and Nationalism in Colonial Modernity " (Oxford University Press 2022), " Sozialismus, Katholizismus und Okkultismus im Frankreich des 19. 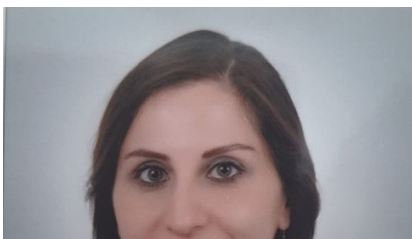


Dr. Fabian VÖLKER

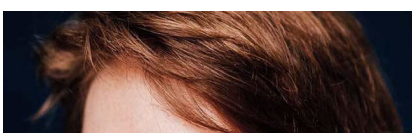
NEW VISITING SCHOLARS: Welcome to RaT!



Dennis Beach, OSB, Ph.D.

Dennis Beach earned his BA in English at Saint John's University in Minnesota and his doctorate in Philosophy at Pennsylvania State University, with a dissertation that examined otherness in Hegel and Levinas: *The Infinite Passion of Responsibility: A Critique of Absolute Knowing*. He is an Associate Professor at Saint John's University and the College of Saint Benedict in Minnesota (USA). His research interests have focused on the work of Emmanuel Levinas, sometimes within phenomenology, but also in the contexts of liberation theology and solidarity work in Latin America and social ethics generally. Teaching interests include the history of philosophy, Heidegger, Philosophy in Literature, as well as Martha Nussbaum's work on the importance of emotional intelligence and compassion in modern democratic societies. His current project involves Hans-Dieter Bahr's philosophy of the guest. Beach is a Benedictine monk of Saint John's Abbey in Collegeville, USA, and has long worked with undergraduate residential life at its college.

Katerina Koci has recently completed her Lise



Meitner Fellowship funded by the Austrian Science Fund (FWF) for the project titled "Woman without a Name: Gender Identity in Sacrificial Stories (M2947-G)" at the Institute for Human Sciences in Vienna. During this fellowship, Katerina published numerous peer-reviewed open-access articles and contributed to volumes. She also organized workshops and public lectures, all focused on her research topic: gendered sacrifice. Katerina is the author of "The Land without Promise: The Roots and Afterlife of One Biblical Allusion" (T&T Clark, 2021).

She resides in Vienna with her husband, Martin, who is also a theologian/philosopher, and their three small children. Her research interests include biblical, feminist, and philosophical-theological hermeneutics, the afterlife of biblical motifs in Christian culture, existentialism, and the phenomenology of sacrificial experience. Katerina draws inspiration from intellectual figures such as Hans-Georg Gadamer, Søren Kierkegaard, Jan Patočka, Jacques Derrida, Julia Kristeva, and Sarah Coakley. Her research delves into topics such as sacrifice, particularly the sacrifice of women, feminine and post-colonial aspects, and violence among subalterns, as well as violence perpetrated by women against women.

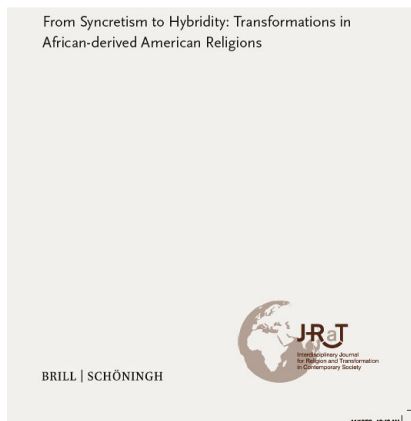

JRAT 9 (2/2023): From Syncretism to Hybridity: Transformations in African-derived American Religions, edited by **Hans Gerald Hödl and Bettina Schmidt**

In this volume, we bring together research on African



derived Religions in Latin America and African American Religions in the USA. Theoretically, the concepts of hybridity and syncretism are discussed in the introduction as well as in the papers included. The papers featured deal with Brazilian Umbanda, Cuban Santería, US African Black Hebrew Israelites, the Five Percenter movement (an offspring of the Nation of Islam), and one single person, Robert T. Browne, an activist in the Black Nationalist movement. In the religions covered – that are an outcome of the historical circumstances of the Trans-Atlantic Slave Trade – elements taken from West and Central African traditions, European Christianity, and Kardecian Spiritism blend to new forms of religious movements. This being the “fundamental” transformation of religion addressed here, some essays in the volume also look at the further transformation of those traditions in a “glocalized” world.

"Zeitenwende" was voted "Word of the year 2022". There was much ridicule that the proclamation of the "turn of an era" was always an expression of an overestimation of one's own epoch. In fact, every era has a need to actively turn its own times around - to help build the future. On the occasion of his 60th birthday, this anthology brings together contributions by companions of the philosopher of religion and dogmatist Karlheinz Ruhstorfer, whose topological approach is particularly committed to the task of productive construction: his intuition - the order of the day is "constellation". By putting together different elements, creative processes emerge that enable productive change - a new identity. This volume explores the question of what such an identity can look like in relation to previous identities from a methodological, theological-philosophical, historical and spiritual perspective.

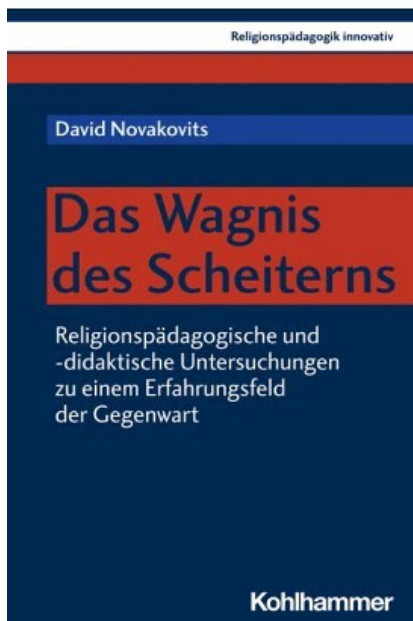

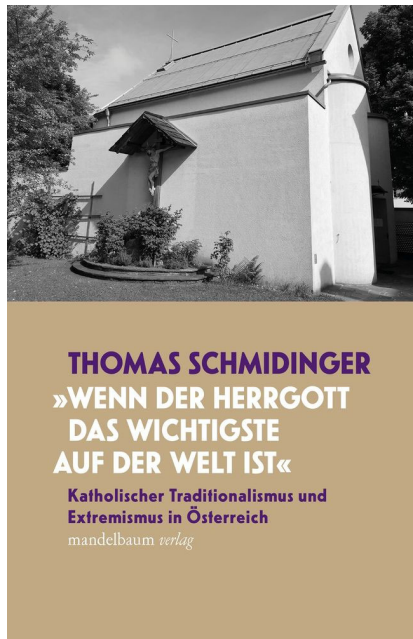
David Novakovits: *Das Wagnis des Scheiterns: Religionspädagogische und -didaktische Untersuchungen zu einem Erfahrungsfeld der Gegenwart.* Stuttgart: Kholhammer 2023.

'Failure' is an iridescent term: it can cause anxiety, but it can also somehow express a particular appeal. At what point do we think that a thing (or a person) has failed, and what exactly do we associate with this expression?

The book tries to describe the social atmosphere of our present more precisely in order to be able to give an answer to these questions. What people understand by 'fail' is different at each time; but what exactly is understood by failure today? What fears are associated with this term? With the help of sociological and philosophical perspectives, the book shows that people today are strongly influenced by the fact that they have to constantly optimize themselves and at the same time they also have to perform and achieve more and more. At the same time, we are thrown back on ourselves in the question of how to shape our lives: There are no longer any religious or cultural grand 'narratives' that answer the question of a successful life per se. The pressure on the individual to create a successful life is thus increasing - and yet at the same time there are also social conditions that significantly shape this seemingly completely individual and private project.

The work tries to work out this tension in the concept of failure. On the one hand, it tries to show that only where a risk of failure is taken, something like new meanings can be found; on the other hand, it elaborates that failure is never just a purely individual experience (or worse: a completely individual guilt). For this very reason, it is particularly interesting who a society perceives as 'failed' and who not.

Thomas Schmidinger: »Wenn der Herrgott das Wichtigste auf der Welt ist«. *Katholischer Traditionalismus und Extremismus in Österreich*. Wien/Berlin: Mandelbaum Verlag 2023.

Catholic traditionalists and extremists regularly take part in rallies against pride parades and the right to abortion, as well as in protests against coronavirus measures. In this, they are much less noticed by the public than Islamist extremists, for example. At the same time, numerous groups are organizing to return Austria to a supposedly ideal world of unity between religion and the state. In terms of church politics, they want to turn back the clock to before the Vatican Council, read Latin masses according to the pre-conciliar rite and consider the Vatican to be infiltrated by a conspiracy of Freemasons and Jews. While some of these currents are trying to infiltrate the Roman Catholic Church from within and bring it back to the "right path", others have completely abandoned the official church and some have even appointed antipopes.

However, this is not just about issues within the church, but also about socio-political ideas. They propagate a rigid gender hierarchy and spread anti-Semitism, anti-Muslim and homophobic resentment. The political scientist and social and cultural anthropologist Thomas Schmidinger has visited masses and events, conducted interviews with priests and believers and thus provides an overview of this scene in Austria for the first time. To this end, he interviewed protagonists and attended masses of the Pius Brothers, St. Peter's Brothers, sedisvacantist and conclavist groups. This field research, in addition to writings by these groups, forms the basis of this monograph.

This article addresses the challenges Catholic theology is facing today. The first chapter analyses current global cultural and social developments, specifically, the increasing megacities, the individualisation and virtualisation of our lives and living environments, questions of migration and neoliberalism, the ecological crisis and, in addition, the search for new narratives that assign meaning to history. The second chapter examines the ecclesial challenges arising from these changes. In particular, the changed roles of women, the necessity to establish a dialogue with other religions and the secular world, the extensive collapse experienced by the clergy in its traditional capacity as the

backbone of the Church and the task of an option for the poor. In light of these analyses an attempt is made to define the current role of theology today and to identify possible tasks. These challenges consist not least of giving a voice to the vulnerability of our being and the possible failure of existence. Contemporary theology is required to discern the meaning of history precisely in the untold and silenced (hi)stories of our world at the margins of society.

This article explores the contingency of the encounter between Jesus of Nazareth and Mary Magdalene that occurs at Jesus's tomb. This article interprets two important passages from the Gospel of Mark (Mk 16:1-8) and the Gospel of John (Jn 20:11-18) to reflect more deeply on this encounter. In Mark's Gospel, the result of the encounter is reference to a never-derivable and unrepresentable beginning, on which the text of Mark is built. The Gospel of John, which refers to Mark, concretizes this as the beginning of love and the covenant partnership between Jesus and Mary Magdalene, which becomes representative for all those who encounter Jesus. It is a contingent encounter because there is no external necessity. We can never realistically expect to meet a dead person again in this world, but the encounter between Mary and the risen Jesus exemplifies a contingency that ends in the freedom of love.

In recent years, Christian-Right activism in Austria has increased significantly and has become more vocal. This article discusses the religious protagonists of the Christian Right, aspects of their narrative and ideology and the impact on their political target audience in two areas


that are central to the activities of the Christian Right in Austria: Anti-genderism/anti-abortion and Christian nationalism.

In October 2023, the FWF approved the individual project *Edition of Paul Tillich's Lectures on Religion and Culture (1955/56)* (P 37167-G). In the open-access hybrid edition project, which will be carried out from January 2024 to December 2026 at the

Department of Systematic Theology and the Study of Religions of the Faculty of Protestant Theology at the University of Vienna under the direction of Prof. Danz in cooperation with the Austrian Academy of Sciences and the Research Centre Religion and Transformation in Contemporary Society of the University of Vienna, Paul Tillich's lectures, which he gave at Harvard University in Cambridge/Mass. in 1955 and 1956, will be edited digitally and as a print edition. This edition of Tillich's late lectures 'Religion and Culture', which bring together his lifelong reflections on the subject of religion and culture, makes his cultural theology accessible to researchers for the first time in a summarized presentation. The edition of the new sources makes it possible to reconstruct Tillich's cultural theology in his late work phase in the USA and to place it in the context of the development of his work.

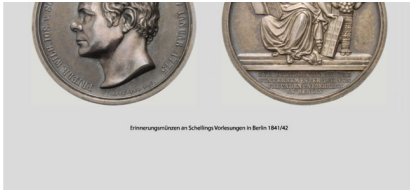

November 09, 2023: Workshop with Prof. Alexander Schnell „Marc Richirs phenomenological Metaphysics”



Prof. Alexander Schnell (Bergische Universität Wuppertal), leading scholar in research on the Belgian philosopher Marc Richir (1943-2015) and one of the most renowned philosophers of the German speaking world, held a workshop on Marc Richir's phenomenological metaphysics at the Research Centre RaT on 09. Nov. 2023. Initially Martin Eleven opened the session by presenting the role of Richir in debates related to the theological turn in phenomenology, the phenomenology of the body (Leib) and connections between Richir and, among others, Merleau-Ponty. Subsequently Prof. Schnell introduced the audience to Richir's highly complex style of thought, major milestones in his development and the ambitious project of a renewal of phenomenology.

Central themes were the fundamental role of fantasy that characterizes Richir's approach to phenomenology, the role of the body within his transcendental phenomenology and his highly demanding transformation of the philosopheme of "chôra", famously introduced in Plato and innovatively re-read by Derrida. Prof. Schnell's remarks lead to a joint reading of the text "Chôra – Topos – Raum. Die transitionale Sphäre als Grundelement der Leiblichkeit" by Richir. The workshop was part of the research network "Transcendental Philosophy, Dialectics and Phenomenology" that was founded in March 2023 in Wuppertal as an ongoing research network between Prof. Schnell's "Department of Transcendental Philosophy and Phenomenology" and RaT.

November 24, 2023: RaT Research Day: Religious Exits: Transitions and Transformations into Alternative Worlds





On November 24, another RaT Research Day took place in Melk. Special thanks go to Noemi Call and Marian Weingartshofer for organizing and moderating the event, as well as to Jakob Deibl and the Abbey of Melk for being our hosts.

Like the last meeting on January 31 of this year, the event was held under the motto "Religious Exits: Transitions and Transformations into Alternative Worlds", the current research focus of the Centre, presented by Kurt Appel in his opening statement. This time it was important for us to offer our new members the opportunity to give an insight into their current religion-related research.

With presentations by: Fabio Wolkenstein, Regina Polak, Kirsten Rüther, Fabian Völker, Uta Heil, Katharina Ivanyi, Deniz Cosan Eke, Wolfgang Treitler, Andrea Lehner-Hartmann, and Martin Fieder.

The long day, characterized by exciting lectures and discussions, was concluded with a guided tour of the monastery led by Jakob Deibl and a joint dinner.

Transdisciplinary Conference 'The Crisis of Democracy – The Role of Religion', 28. November 2023, Mayor City Hall, Vienna/ Austria

Based on the results of the interdisciplinary study 'Values - Politics - Religion: The European Values Study. In-depth Analysis - Interdisciplinary Perspectives - Future Prospects' (ed. Regina Polak/Patrick Rohs, July 2023) and the latest COVID special editions of the European Values Study for Austria 2021/22, the transdisciplinary conference 'The Crisis of Democracy – The Role of Religion' took place under the direction of Assoc. Prof. Dr. Regina Polak (Catholic-Theological Faculty of the University of Vienna) on November 28, 2023, in the Mayor City Hall of Vienna. The conference is a project of the 'Interdisciplinary Values Research Network' at the University of Vienna.

100 participants from academia, politics, business, the education system and religious communities spent a day discussing the ambivalent effects of subjective religiosity on attitudes that are relevant to the stability of the liberal, human rights-based democracy. Despite a high level of formal approval of democracy, fractures in the foundations of democracy became evident throughout Europe and also in Austria, as presented in the key-lectures of Susanne Pickel (University of Duisburg Essen) and Gert Pickel (University of Leipzig). Among people with an 'uninformed understanding of democracy' autocratic ideas can also be found in democratic self-images, which results in a hidden crisis of the legitimacy of democracy. In addition to social inequality, materialistic values, nationalism and racism, this result can also be explained by religiosity in some sections of the population. The impact of religious attitudes and practises on democratic values turned out to be ambivalent. However, while an active, socially committed membership and a

religiosity open to plurality can even promote democratic attitudes, exclusivist religiosities are significantly more frequently associated with anti-democratic attitudes. According to the empirical results, the bridge between anti-democratic and religious attitudes is primarily formed by prejudices against minorities, in particular against Muslims, Jews and same-sex people. In dealing with these findings, the conference participants developed concrete ideas and perspectives for action on how the role of religion in promoting democracy can be strengthened by both religious communities and political actors.
