### Dr. Anna HAGER, MA

*Faculty of Protestant Theology  
Department of Systematic Theology and the Study of Religion*

I am currently a postdoctoral research fellow (Hertha Firnberg fellowship of the FWF) at the Faculty of Protestant Theology where I am working on the Syriac Orthodox community in Lebanon (1918–1982).

My research includes modern Islamic movements, Christians in the Middle East and Christian-Muslim relations. I previously held research and teaching positions at the Department of Near Eastern Studies at Princeton University and the Institute for Eastern Christian Studies (IvOC) at Radboud University in the Netherlands. At IvOC I worked on the conversion of half a million Mayas to the Syriac Orthodox Church in Guatemala. My book *Christian-Muslim Relations in the Aftermath of the Arab Spring: Beyond the Polemics over “The Innocence of Muslims”* appeared with Edinburgh University Press in 2024. Academic Studies Press is currently preparing a translation into Russian. I recently initiated the Network Promoting the Field of Middle Eastern Christianity with a quarterly newsletter (<https://etfst.univie.ac.at/ueberuns/team/anna-hager/#c1090498>)

## Ass.-Prof. Dr. Tugrul KURT, BA MA

*Faculty of Catholic Theology  
Head of the Department of Islamic-Theological Studies*

My research is grounded in the comparative study of religious texts, with a particular focus on Quranic studies and exegesis as they pertain to interreligious dynamics and historical context. A core component of my work involves a comparative approach to the Qur'an, analyzing it not only as a foundational Islamic text but as one deeply shaped by the socio-religious landscape of the Late Antiquity. This approach includes examining intertextuality and surrounding cultural texts that inform the Qur'an's engagement with pre-existing religious frameworks, particularly through isrā'īliyyāt narratives that reveal early interreligious connections.

By applying a historical-critical and hermeneutic methodology, I seek to uncover the Qur'an's complex theological dimensions and its interaction with contemporary intellectual currents. Situating Islamic studies within a broader interreligious and comparative framework, my research promotes constructive engagement with diverse theological and academic perspectives. At the University of Vienna, I aim to advance this interdisciplinary approach, positioning Islamic theology as a vital contributor to global religious scholarship.



### RaT Series (Volume 35): *Die Hyperbolé der Wirklichkeit. Metaphysik nach dem Ende der Metaphysik*, by Sandra Lehmann

This book develops the thesis of the hyperbolic character of being against the background of the 20th century's critique of metaphysics. A hyperbolic concept of being opens up a different perspective on historical and systematic questions. It makes it possible to indicate what drives the many, often very different approaches in the history of metaphysics. But it also shows how metaphysical thinking can be continued. The key to both is a hyperbolic ontology that deals with the inner excess of reality.



## PUBLICATIONS: Monographs & Anthologies



**Christian Danz:** *The Theology of Paul Tillich. Contexts and Key Issues.* Macon/Georgia: Mercer University Press 2024.

THE THEOLOGY OF PAUL TILLICH examines Tillich's main theological work, the three-volume Systematic Theology, against the background of Tillich's developing theological thought since his studies around 1900. While the Systematic Theology emerged from lectures Tillich gave at Union Theological Seminary in New York from 1936 onwards, his lectures on "Advanced Problems in Systematic Theology" take up considerations that go back to his first drafts of a systematic theology from 1913 and his dogmatic lectures from Germany in the 1920s. The Systematic Theology that Tillich published in the U.S. cannot, therefore, be understood without including his German dogmatic drafts, an area of Tillich research that has previously been underrepresented in English scholarship. The volume presents a concise introduction to Paul Tillich's thought in the context of twentieth-century Protestant theology and a clear direction for responsible appropriations of Tillich's theology today.

**Christian Danz (ed.):** *Der junge Paul Tillich und die Theologie um 1900. Theologie – Wissenschaft – Religion.* Berlin/Boston: De Gruyter 2025.

The development of the theology of the young Paul Tillich has been little researched to date. Although there are studies on his reception of Fichte and Schelling, the significance of his academic theological teachers and the theological debates around 1900 for the formation of his own theology has surprisingly not



been the focus of research. This volume is the first to address in detail the theological-historical background to his theology as well as the young Tillich's engagement with the theology of his teachers in Halle in the period between 1905 and 1919.

**Christian Danz, Marc Dumas and Werner Schüßler (eds.):** *The Future of Protestantism. International Yearbook For Tillich Research 2023/2024*. Berlin/Boston: De Gruyter 2024.

Volume 16 of the International Yearbook for Tillich Research, entitled *The Future of Protestantism*, explores Tillich's interpretation of Protestantism from historical, contemporary diagnostic, work-historical and systematic perspectives. In numerous publications, Paul Tillich has expressed his views on Protestantism in the context of modernity. This theme runs through his entire oeuvre and is one of the significant components of his theology. Protestantism here means above all a critical principle. However, Tillich does not stop at criticism from the point of view of the unconditional, but also addresses the historical realization of Protestantism and a possible end of the Protestant era.

**Mădălina Diaconu:** *Aesthetics of Weather*. London/New York: Bloomsbury Academic, 2024.


In an age of rife consumption, the aesthetics of weather becomes vital for fostering sustainable patterns of behaviour and for improving scientific communication. In response, offering the first in-depth examination of the aesthetics of weather, this book analyses multisensory atmospheres and the 'art in the air', whilst rejecting the short-sighted 'consumption' of landscapes and fine weather.

With its broad range of inquiry ranging from Aristotle to eco-phenomenology, from the pioneers of meteorology to contemporary art, and from everyday aesthetics to waste management, this book calls attention to the global and intergenerational implications of individual practices and argues that an aesthetics of weather can become a valuable ally to climate ethics in the Anthropocene.

**Mădălina Diaconu, and Zhuofei Wang (eds.):** *Atmosphäre: polylog. Zeitschrift für interkulturelles Philosophieren* 51/summer 2024.


This issue of the journal *polylog*, edited by Mădălina Diaconu and Zhuofei Wang, collects papers in





German and English that introduce to the European phenomenology of atmosphere (Jürgen Hasse), detect equivalents of this concept in Japan (Kantaro Ohashi) and the Arab world (Mounira ben Mustapha Hachana), explore analogies with Indian philosophy (Srisrividiya Kalyanasundaram & Sandhiya Kalyanasundaram) and analyse social atmospheres on the example of Brazil (Paulo Gajanigo). The papers are preceded by two substantial introductions by the editors on characteristics, challenges, and implications of the theory of atmosphere and on its relevance to intercultural philosophy.

**Anna Hager:** *Christian–Muslim Relations in the Aftermath of the Arab Spring: Beyond the Polemics over "The Innocence of Muslims"*. Edinburgh: Edinburgh University Press 2024.

In September 2012, a video titled “The Innocence of Muslims” provoked widespread condemnation and protests in the Middle East. It depicted an attack on Copts by a presumably Muslim group, connecting it with the prophet of Islam, Muhammad, portrayed as a ruthless killer and child-molester. Although the video could have had dramatic consequences for Christians in the region, since Coptic individuals living in the US had produced it, the controversy turned instead into a moment of Christian–Muslim unity.

This book uses this controversy as an entry point into the study of relations between Christians and Muslims in Egypt, Lebanon and Jordan. Instead of dismissing the condemnations and joint reactions as shallow and ritualised displays of solidarity, Anna Hager argues that they offer insights into the mechanisms of Christian–Muslim relations. Christians and Muslims, including Islamist figures, channelled the potential violence – turning it into an occasion to strengthen inter-communal relations and, crucially, their own positions.




**Rudolf Langthaler (ed.):** *Kant - eine bleibende Herausforderung für das Christentum? Zur Aktualität des kantischen »Projekts der Aufklärung«*. Baden-Baden: Karl Alber 2024.

Kant's challenge to Christianity and the churches is still highly topical: his questions and problematizations of the “proofs of God”, the “divine sonship of Jesus” and his “vicarious atoning death”, the topic of “grace” and the relationship between “theonomy versus autonomy” are still largely unanswered by theologians and, above all, the church. Kant's 300th birthday would probably be a fitting occasion to address these deficits in an appropriate manner. Philosophers, theologians and also important church officials were therefore invited

to comment on the topics mentioned - but unfortunately this invitation was met with numerous refusals on the part of the church and theologians...

**Rudolf Langthaler, and Magnus Striet:** *Vernunftreligion statt Kirchenglaube? Kants unerledigte Anfragen an die Theologie.* Freiburg i. Br.: Herder 2024.

It is certainly doubtful that Immanuel Kant was an orthodox Christian when measured against the ideas of church orthodoxy at the time and today. However, this cannot be a reason to avoid the questions that he posed with unwavering clarity to central convictions of Christian theology. These by no means only concern the understanding of freedom, which he fundamentally changed, but also classical theological ideas of Jesus' sonship with God and his substitutionary atoning death. While Rudolf Langthaler reconstructs these questions directly from Kant's work, Magnus Striet explores ways of addressing them in a theologically constructive manner. Both share Kant's conviction that "a religion that unhesitatingly announces war on reason" will "not be able to withstand it in the long run".

**Madalina Diaconu:** *The Fragrant Seal of the Spirit: the Aesthetics of Chrism*, in: ESPES. The Slovak Journal of Aesthetics 13:1 (2024): "Olfactory Aesthetics", ed. by Madalina Diaconu, 64-80.

Despite recent developments in the fields of olfactory aesthetics, phenomenology of liturgy, religious aesthetics, and theological aesthetics, the complex presence of odours in the Christian culture has been scarcely discussed. This study is meant as a contribution to a future systematic exploration of the aesthetic 'osmology' of theology, by focusing on the fragrant chrism oil (in the Eastern Church called Holy Myron). Technical-historical explanations regarding the olfactory composition, preparation and use of this sacramental oil are followed by an examination of the semantics of its odour in patristic theology and medieval popular imaginary. This rich symbolism has been lost in the 'anosmic' modern Catholic and Orthodox sacramental theology.

**Madalina Diaconu:** *Nebulous landscapes and the aesthetics of indeterminacy*, in: *Lebenswelt* 23/2023: Landscapes. An atmospheric approach, 174-188.

A landscape is commonly conceived as an arrangement of items on solid or liquid surfaces. Despite its entanglement with the landscape, the weather condition tends to be overlooked. The liminal case of a thick fog that suppresses the view of the environment challenges this standard understanding. The paper examines the experience of being lost in fog with respect to perceptual, spatiotemporal and emotional aspects. Fog suspends the everyday scopic regime and the inconspicuous 'immateriality' of air as medium of perception, distorting the patterns of perception and temporarily installing an own spatiotemporality. Moreover, fog is an atmospheric phenomenon par excellence, a quasi-thing and a quasi-agent that is usually felt as distressing and maleficent yet may trigger a

sense of wonder as well. While it is considered a deficit in epistemic issues, nebulosity has a strong aesthetic expressivity, whose sources range from semantic ambiguity to defamiliarization and the transfiguration of the ordinary.

**Andreas Telser:** *Digitalität – Privatheit – Ästhetik*, in: Ethik und Gesellschaft. Ökumenische Zeitschrift für Sozialethik (2/2024).

Covid-19 has not only kept many of us behind screens for longer, but has also made us realize 'afterwards' how much digitality had already begun to change our ideas of privacy 'before'. Late modern subjects can't help but creatively juggle their permanently 'curated' identity at the liquefied boundary between private and public. By reminding public theology of the time and milieu in which it emerged, Shawn Copeland looks into its 'blind spots'. The public sphere is also the unthinking condition of possibility for racist action and suffering. In the context of "black culture", Kevin Quashie places an "expressiveness of quiet" alongside the attention-seeking public. Contrary to appearances, this expressiveness is by no means apolitical, but rather recalls an ultimate inexpressibility of every subject.

## **7 January 2025: Deadline for the Call for Papers of the Workshop "Körper(lichkeit): Locus theologicus - Lebensrealität - Territorium" (13-15 June 2025)**

The body and corporeality are once again becoming a challenge for contemporary theology - not just 'still', but 'increasingly so': it is at the centre of political conflicts around the world. This can be seen both in the global rise of right-wing populism and anti-democratic forms of government and the associated attacks on women's and minority rights, LQBTQIA+ people and reproductive and sexual self-determination, as well as in the largely unbroken continuity of dogmatic-repressive positions on sexuality and gender relations in religious communities and churches. The aim of this international workshop is to reflect theologically on different areas of tension in relation to physicality and to bring approaches into dialogue with each other.

**Echokammern der Niedertracht. Erdoğans AKP und die antisemitische Propaganda auf X im Nachklang des Hamas-Terrorangriffs**

In contemporary society, we are witnessing a growing dynamic in which ideological and political narratives are deliberately shaped and amplified in digital

spaces. Authoritarian contexts, in particular, provide fertile ground for the use of such mechanisms to pursue political goals that exacerbate social tensions.

The research project "Echo Chambers of Malevolence: Erdoğan's AKP and Anti-Semitic Propaganda on X in the Aftermath of the Hamas Attacks" examines these developments through the case study of Turkish anti-Semitism. It focuses on tweets published between October 7 2023 — the date of the attack on Israeli civilians — and April 1 2024. This specific timeframe was chosen based on the assumption that the Turkish government's stance, alongside manifestations of anti-Semitism, anti-Zionism, and anti-Israel sentiment, will remain consistent as the conflict continues and elections approach (local elections took place on March 31, 2024). The project aims to highlight the specific characteristics of Turkish anti-Semitism by analysing its development and dynamics within political discourses, as well as its impact on German-speaking societies.

By linking anti-Semitic discourses, political agendas and digital communication strategies, this interdisciplinary project highlights how these elements shape public opinion and deepen societal polarisation.

## January 30, 2025: Symposium "Psychoanalyse - Recht - Religion"

Interdisziplinäres Symposium zur Bedeutung und  
Aktualität von Pierre Legendres 'dogmatischer  
Anthropologie'

Pierre Legendre, one of the most important thinkers of our time, died in 2023. In more than 60 years of scientific activity, he left behind an extensive oeuvre comprising over 40 monographs, more than 150 scientific publications and several documentary films. However, the full scope and numerous ramifications of his work, which is known as 'dogmatic anthropology', has not yet been fully recognised. The aim of the German-language symposium is to discuss the relevance and topicality of Legendre's work from the perspective of law, religion and psychoanalysis. ## Valedictory lecture by Prof Hans Gerald Hödl

On October 22, 2024, the valedictory lecture of H. Gerald Hödl, a founding member of the Research Centre RaT, took place. Gerald Hödl was on the board of our centre for a long time and is a member of the editorial team of JRAT. Particularly noteworthy is the publication of the special issue "[From Syncretism to Hybridity: Transformations in African-derived American Religions](#)" (2/2023, together with Bettina Schmidt) and his article "[Reversed Racism: Fundamentalist Genealogies in African-American Religions](#)" (2/2016).

His farewell lecture was entitled "**Der "afrikanische Hochgott" - Faktum oder Fiktion**" and once again demonstrated Gerald Hödl's extensive knowledge of African religious traditions. With the question of the "High God" (Hochgott), he brought a category of European research history into play and traced its role in accessing African traditions. He kept the large audience in suspense with the question of whether the category of the high god is a fact or a fiction, only to ultimately prove it to be unanswerable, even irrelevant. It is an expression of the self-reflection of European research history and has more to do with it than with the uniqueness of African religious traditions.



## Workshop „Reading Walter Benjamin’s Origin of the German Trauerspiel“

From 24th to 25th of October RaT-members Sandra Lehmann and Daniel Kuran organized a workshop on Walter Benjamin's famous work *Origin of the German Trauerspiel*. The event was hosted by the Department of Intercultural Philosophy of Religion and by the Research Centre for Religion and Transformation. International as well as local experts in research on Walter Benjamin contributed to the event with their insightful and multifaceted presentations. Nassima Sahraoui, Sven Schöpf, Sebastian Truskolaski, Stefano Marchesoni, Stephanie Graf, Daniel Gönitzer, Sandra Lehmann, and Daniel Kuran held talks on many different aspects of Benjamin's book. Through presentations but also through reading sessions the participants accessed one of Benjamin's richest, but also most difficult and dense texts that has challenged readers for nearly a century since its publication. The contributions dealt with Benjamin's understanding of epistemology, history, eschatology, baroque, sovereignty, allegory, martyrdom, but also with very concrete motifs and figures as the ruin, Dürer's *Melencolia I*, baroque dramas by Gryphius, Lohenstein a.o., that all play a significant role in Benjamin's book.



## RaT Research Day

The annual RaT research day took place this year on November 22. As with the last edition, we were lucky enough to be able to spend this day together at Melk Abbey. After arriving together by train, the participants were able to get an impression of the wide range of approaches to religion united in the RaT Research Centre during a packed program of lectures.

**Christoph Augustynowicz**, who together with Kirsten Rüther, was recently appointed as the center's new deputy speaker, presented his current research on the work of social historian Roman Rosdolsky. **Nikola Pantic** from the department of Near Eastern Studies then spoke about the development of charismatic holy orders in the Ottoman Empire. Finally, before the start of the lunch break, **Katerina Koci** used the biblical figure of Sarah to present the central thesis of her FWF Elise Richter project "Two Sarahs: Victimhood in the Bible and Its Reception": that victims of patriarchal exploitation can become perpetrators themselves.

After lunch in the Stiftsküche, the lectures were continued by **Madalina Diaconu**, who presented her fascinating, recently published book on "Aesthetics of Weather", in which she shows that our experiences and discourse on weather phenomena are linked in many ways to cultural and religious images. After her, **Arno Böhler** took the stage and presented the philosophical background of his current FWF research project, which deals with the concepts of the \*heart\* in the works of the German philosopher Nietzsche and the Indian thinker Aurobindo.

**Ikenna Okafor** then presented his current project, in which he combines the fields of theology and literature with the work of the Nigerian writer Chinua Achebé and examines the role played by the image of the "crossroads". To conclude the day, religious education researcher **David Novakovits** presented his theories on "agonal learning" and the productive role conflict can play in religious education.

The intensive day finally came to an end with a joint dinner in the abbey. We are already looking forward to the next edition!
